I have PhD in Natural Resource and Environmental Economics, M.A. in Economics and BSc in Agriculture. At KIPPRA, I joined as **Policy Analyst in July 2000** and was promoted to **Senior Policy Analyst and Programs Coordinator in July 2003**. As Programs Coordinator my work included:
