KEY QUALIFICATIONS

Cooperation strategy processes: Mr Drakenberg has contributed with expert advice in numerous cooperation strategy processes at Sida, typically starting with providing analytical input in the form of environment and climate change policy briefs and later discussing and commenting on assessments or draft strategies. In some recent cases it has included participation during the initial assessment, the start-up meeting, the actor meeting, by providing thematic input to the country teams and substantial dialogue with the country teams, including a commitment to provide expert advice during the implementation in specific areas.

Capacity development and training on environment: Close to 20 years of professional experiences from working with building capacity for environmental mainstreaming in large organisations. Mr Drakenberg has led the development of pedagogical materials, e-learning tools, workshops and doing training and coaching for Sida, the private sector and academia. He is a frequent lecturer/speaker/moderator and is well informed on how other bilaterals and multilaterals are addressing these issues.

Integrating climate change adaptation in development cooperation: Mr Drakenberg has worked closely with Sida on developing guidance on how best to address climate change adaptation in Sida's work and analytical tools. He has supported Sida in international processes on the subject and has expertise in climate finance.

Harmonization of development cooperation methods and approaches: The aid effectiveness agenda calls for harmonized approaches and impacts on Sida's way of working. As expert, Mr. Drakenberg has assisted Sida in more than 10 OECD DAC/EPOC task teams and international meetings and contributed to the dialogue and in writing to development of guidance documents for international development cooperation. Integration of environment in budget support processes is one such example.

Country economic analytical work: The economic and distributional impacts of environmental degradation and climate change are seldom well described and communicated to policy makers.

Economic arguments carry substantial weight and Mr Drakenberg has specialized in identifying how environmental valuation techniques, natural resources accounting and existing economic information better can be used to inform decision making at country level, including national planning processes.
