On my return from Sida, I picked up my previous work at Sida's Helpdesk for Environment and Climate change (for information about the Helpdesk contract see the section May 2011 below). When the vice-chancellors of our two host universities initiated Global Sustainable Futures (GSF) in 2020 GSF became my main focus. GSF aims to increase collaboration within research, teaching and utilization with universities in Low- and Middle-Income Countries. My responsibilities have included the development of a webinar series with the involvement of researchers in the Global South, planning and facilitating academic conferences, network development and fundraising. In 2021 I led an international consortium bidding for a Global Leadership programme for Transformation (Sida, Vinnova, SI). Recent support to Sida has included strategic input to the unit responsible for the strategy for Sweden's global development cooperation in sustainable economic development (GLOBEC). Other examples include a brief on climate economics in collaboration with Thomas Sterner/Anders Ekbom and a report on Environmental taxation.

I was employed in the department for international organisations and thematic support. Firstly, I was engaged in negotiations on climate finance, involved in preparatory meetings at the Swedish and EU levels and as Sida's representative in the delegation at COP 23. Secondly, I was employed as a programme manager at GLOBEC where I managed Sida support in areas of Trade and Green financing. The work involved rigorous administrative procedures in appraising development

programmes, careful programme follow-up, partner dialogues with UN organisations and international think tanks, donor coordination meetings, gender mainstreaming and anti-corruption measures.

During this period my work consisted of two parts. The first giving expert advice to Sida and to co-manage the Helpdesk contract. The Helpdesk contract involves about 12 persons based at GMV or the Swedish University of Agricultural Sciences, SLU. The second part consisted of a variety of activities such as evaluations, studies and lecturing/coaching.

Sida's Helpdesk for Environment and Climate change provides a number of services for Sida. As an expert I; a) analyse the environment and climate situation in Sida's partner's countries and give advice on possible implications for Swedish development cooperation; b) comment and advice on specific development projects; c) co-develop methods and tools; d) write thematic analysis; and e) coach and train Sida staff and facilitate workshops for Sida and their partners in more than 10 countries in the Global South.

On numerous occasions, Sida has asked me to participate in international fora such as OECD DAC, the Poverty-Environment Partnership and the Donor Committee for Enterprise Development. My international network includes many donor agencies, banks and international NGO's and I was a long term member of the Technical Advisory Group for the UNDP-UNEP Poverty Environment Initiative.

Outside of the Helpdesk contract I mainly engaged in evaluations, studies, research projects and lecturing. For example, I led a team that evaluated IIED's Environmental economics programme and on behalf of UNDP I have reviewed the One UN Poverty Environment Initiative. I have a special interest in methods to increase the knowledge exchange between researchers and other stakeholders for better impact. I have lectured on this topic in PhD courses in Sweden and in academic contexts in the Global South. For more than five years I have been an advisor on research policy interaction for the Environment for Development Initiative (EfD).
